ORAL ORDER

- 2 31-08-2022
- 1. Heard the parties.
- 2. Learned counsel for the petitioner submits that the petitioner has been transferred vide order dated 9th July, 2022 from the University to the Constituent College namely A.N.S. College, Navinagar. Although, the petitioner is on the cadre strength of University. He submits that the transfer is illegal and the respondents do not have any authority to transfer the employee of the University to a Constituent College.
- 3. It is further pointed that the recruitment for the staff and employees of the Constituent College is senarately

non-teaching staff. It is further submitted that the statutes only provide for transferring an employee from one Unit/Department or establishment of the University to another, but not to a Constituent College.

- 4. Learned counsel relies on an order passed by this Court in C.W.J.C. No. 10176 of 2022 (Kanan Raju Vrs. The State of Bihar & Ors.), dated 28th July, 2022, wherein similar question was raised and a reliance was placed on Judgment reported in 2001 (4) PLJR 484 (Prashant Kumar Suman Vrs. The Vice Chancellor, L.N. Mithila University & Ors.). Learned counsel also relies on a Judgment passed by a Co-ordinate Bench in C.W.J.C. No. 13622 of 2010 (Rajendra Singh Vrs. Jay Prakash University, Chapra & Ors.), dated 06.09.2010, wherein such a transfer was quashed by the Co-ordinate Bench holding that there is no unified cadre of the employees of the University and Constituent College.
- 5. Learned counsel appearing for the University wants time to file his reply. However, he has taken this Court to the amendment made in the Statute dated 04.03.2014 to submit that as per Clause X (c) of the said regulations brought into force

control of the University. Learned counsel submits that the establishment under the control of University would also mean the Constituent College.

- 6. The matter to be examined. The reply may be filed.
- In the meanwhile, till further orders the effect and operation of the order dated 9th July, 2022 shall remain stayed.
- 8. The petitioner shall be allowed to perform his duty at the place where he was working prior to passing of the order dated 09.07.2022 and it shall also be allowed to draw salary.
 - 9. List this case after four weeks.
